This contract is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and among the understanding Valley High Quarter Horses agent Debra Powell (Stallion Owner), and \_\_\_\_\_, Mare Owner agrees to breed the mare registered as \_\_\_\_\_

Registration # \_\_\_\_\_, Breed \_\_\_\_\_, to the Stallion ***Blazing Invitation, AQHA # 4494520*** during the 2010 breeding season. (Commencing February 1<sup>st</sup>, and ending July 1<sup>st</sup> 2010)

Upon signing, Mare Owner agrees to pay a non-refundable booking fee of USD \$250.00. to reserve a breeding to said Stallion for the year 2010. The booking fee shall be applied to the Stallion Service Fee of \$500 (discounted from \$1000) plus a \$300 collection fee, with discounts applying as indicated. Mare Owner agrees to pay the entire Stallion Service Fee, including the booking fee, prior to any shipment of semen. Total fee which includes the cost of the vet and stallion handlers for collection, will be \$800.00 plus shipping costs, less any additional (early payment, multiple mare) discounts that apply. Additional shipments will be charged a collection fee of \$300 plus the cost of shipment. Additional discounts \$\_\_\_\_\_.

Mare owner warrants that the mare is healthy, in sound breeding condition and is registered with a recognized breed association noted above. A current copy of the mare's registration papers must be attached to this Agreement. Mare Owner further warrants registration papers are accurate.

Both Parties agree to diligently try to settle Mare. If Mare does not settle, Mare Owner will hold Stallion Owner and Farm harmless from any loss or damage. Stallion Owner guarantees that a single Live Foal will result from the breeding privilege granted herein. The term "Live Foal" means that one foal resulting from the breeding stands alone, nurses and lives for twenty-four hours. If a Live Foal does not result from the breeding, Mare Owner will be entitled to rebreed Mare to Stallion in the immediately subsequent breeding season. The Live Foal guarantee is void unless the following conditions are met:

*Mare Owner notified Stallion Owner within forty-eight hours of foaling that the mare did not produce a live foal: and within 14 days after Mare Owner's notice to Stallion Owner, the Mare Owner certifies to Stallion Owner with a statement from a licensed veterinarian details explaining the failure of the mare to produce a live foal.*

*If Mare dies or is deemed unable to carry a live foal, a substitute Mare may be used with permission from the Stallion Owner with prior written agreement.*

If the Stallion dies, is sold, or becomes incapable of servicing mares for any reason and Mares have not been bred, this Agreement will become null and void and all fees will be refunded and the parties to this agreement will be released from any further liability.

This Agreement constitutes the entire agreement between the parties.
